In the event that any of my pets appear to be ill, injured or at significant risk of experiencing a medical problem at the start of service or while in the care of The Daily Dog, LLC, I give permission to The Daily Dog, LLC to seek veterinary care/services from a veterinarian or veterinary clinic as close to the incident as possible.

My preferred vet is listed on each individual pet’s information above. Other veterinarians or emergency care clinics chosen by the pet sitter are acceptable.

I ask The Daily Dog, LLC to inform the attending clinic or veterinarian of my requested total diagnosis and treatment limit of \$ \_\_\_\_\_ per pet. (Most common values are \$200, \$1,000 or unlimited). I understand that efforts will be made to contact me regarding any treatments, illness, injury or potential problems as soon as the condition is deemed not life threatening and/or contact is possible.

I understand that The Daily Dog, LLC and their professional pet care providers work hard to prevent accidents and injuries, and that such problems may occur no matter how well a pet is cared for. I agree to allow The Daily Dog, LLC and its providers to use their best judgment in handling these situations, and I understand that The Daily Dog, LLC and its staff, assume no responsibility for the actions and decisions of the veterinary staff, the health or death of my pet(s).

I will assume full responsibility for the payment and/or reimbursement for any and all veterinary services rendered, including but not limited to Emergency Care Form, diagnosis, treatment, grooming, medical supplies and boarding. Such payments will be made within 14 days of the initial incident. I also agree to be responsible for all Special Service fee assessed by The Daily Dog, LLC for emergency transportation, care, supervision, or hiring of emergency caregivers, and will pay such fees within 14 days of each incident.

I further authorize The Daily Dog, LLC and my primary veterinarian to share all of the medical records of all of my animals with veterinary clinics in an emergency, in the interest of providing the best care for my ill or injured animal(s).

**Every animal under the care/service of The Daily Dog, LLC, will be current (per my veterinarian’s recommendations) on its rabies vaccinations prior to the arrival of any caregiver. I will also make arrangements to guarantee that each animal will remain current on its rabies vaccinations throughout each service visit period. I agree to upload proof of vaccination to The Daily Dog’s pet software program, initially and on an annual basis.**

I agree to notify The Daily Dog, LLC of any signs of injury or possible illness before any visit as soon as the condition appears. The Daily Dog, LLC reserves the right to cancel service at any location where a pet with a potentially infectious condition exists. The Daily Dog, LLC strongly recommends that each pet be vaccinated, de-wormed, and protected from harmful insects according to veterinarian recommended standards.

This agreement is valid from the date below and grants permission for future veterinary care without the need for additional authorization each time The Daily Dog, LLC cares for one or more of my pets. I understand that this agreement applies to all of the pets within The Daily Dog, LLC’s care. In signing this contract, I agree that I have the sole authority to make health, medical and financial decisions regarding the animals that will be scheduled to receive services.
